Subject: Ongoing investigative findings involving Directed Energy civilian-victim cases

Overview

This report summarizes patterns identified in ongoing investigations involving Directed Energy harassment and assault against civilian victims across the United States. Evidence from incident reports, interviews, and documented behavioral patterns indicates a coordinated system of remote psychological and physical interference.

Three Primary Components

1. SOUNDS (Psychological Intrusion)

Manipulated human or AI-generated voices projected into the victim's cognitive space. These often involve hateful, degrading, or coercive messages delivered continuously.

External Voices: Active & Passive Assaults

Directed external voices manifest in two forms:

Active Assaults

Voices intentionally used to bully, tease, threaten, or antagonize the victim, forcing them into a state of hypervigilance and psychological distress.

Passive Assaults

Victims are unaware the voice is not their own internal thought. This covert form of intrusion is designed to influence emotions, decisions, and behaviors without the victim's conscious awareness.

These operations require an extreme level of hate and disregard for human life. Criminal misuse of this technology is built on a "foundation of criminality" designed to:

- Conceal the identity of the users
- Hide the physical location of operators

- Prevent public recognition of technology capable of remote neurological access
- Influence behavior without the victim's knowledge or consent

Some offenders attempt to misdirect blame onto AI or autonomous systems, claiming they operate independently. This is false. AI does not choose victims or inflict neurological torture on its own, without being programmed to do so.

Victims are often misled to believe **Wi-Fi is the source** of their neurological attacks. Research is necessary to determine if in fact Wi-Fi (energy) is also used to remotely connect to victims.

2. VISUAL PROJECTIONS (Cognitive Interruption)

Remote projection of images, scenarios, nightmares, or video-like sequences into the victim's internal visual field. These appear as artificially induced dreams, daydreams, mental imagery, or intrusive visual content.

3. PAIN (Physical Assault)

Physical pain induced through directed-energy mechanisms, including microwave exposure, electromagnetic frequency attacks, electroshock sensations, neurological pain, and targeted pressure or burning.

Observed Criminal Behaviors

Ongoing investigations document repeated use of directed-energy tools to psychologically destabilize and physically weaken victims. Identified tactics include:

- Projecting intrusive or fabricated images into the mind
- Repeating or replaying nightmares
- Remotely altering or interrupting sleep cycles
- Coordinated stalking and monitoring
- Inducing neurological pain, burning, pressure, or electroshock sensations

Conclusion

These technologies represent a direct threat to cognitive privacy, physical safety, and mental well-being. DEW Police will continue documenting, analyzing, and reporting these patterns to advance investigative accuracy, promote public awareness, and support the need for federal recognition, legal protections, and intervention.
